2. The quotations which are not in a sealed cover or not super scribed as indicated above shall be rejected summarily
3. The price quoted should be inclusive of all taxes and other Govt. levies etc.,
4. The rate should include the loading, unloading, transportation to deliver at REC, farm and the weighment of the load should be confirmed with weightment slip at the time of supply.
5. FYM should be of good quality, fully decomposed and free from soil, sand, stones, plastic materials etc., Moisture content should not be more than 30%
