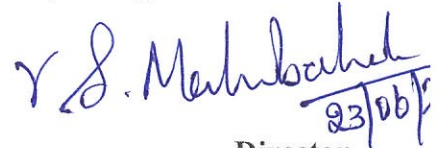
Title of the project "**Toxicological evaluation of sericin, fibroin, pupae powder and chitosan extract from organic cocoon of silkworm *Bombyx mori* in animal model**" (Code: BPS01056SNC)

1. **Tenure of the project:** project assistant tenure Nov 2025 to Oct 2026 or completion of the project/ whichever is earlier.
2. **Essential Qualifications:** B.Sc in Agriculture/ Life Science/ Chemical Science with a minimum of 55% marks (50% for SC/ST candidates).
